- any Receivables Management Certification Program standards and how it relates to the subject matter, if applicable.

Programming

- *Sales pitches for your products and services are not acceptable.*

Presentation Selection

All presentation proposals received on or before **August 5, 2019** will be reviewed by RMAI's Conference Committee and presenters will be notified only of their acceptance by **October 1, 2019**.

Selection will be determined based on:

- appropriateness and interest of topic,
- level of content,

- comprehensiveness of session objectives, and
- expertise of presenter.

*Preference is given for interactive presentations as well as programs that are centered around audience interaction.

****RMAI reserves the right to make recommendations for revisions of content within proposals or addition of speakers prior to acceptance. Participation as a presenter is by invitation only after review of the proposal.**
